2) Committee felt we would charge for electric usage, funding from TIF funds Trustee Meade made a motion, seconded by Trustee Wells, to approve purchase and installation of a dual-port EV charging station at 2 parking spots, from Tri-City Electric at a cost NTE \$7300, from TIF funds

1) Jared expects Mr. Shew to come to the Board at a future meeting

- c. They feel the resurfacing/repair of 9<sup>th</sup> Avenue is one of the most important projects in the Village at this point
  - 1) Not sure of potential for TIF funding, may need to discuss with TIF attorney
  - 2) Total cost should be around \$140,000
  - 3) Task Order from MSA in Trustee packets to assist Village in completion a) MSA fee \$25,800

#### 9. ORDINANCE, GRANTS & AUDITS PATTY LINDLEY

a. Prevailing Wage Ordinance #171906 – Trustee Lindley read the Ordinance aloud Trustee Wells made a motion, seconded by Trustee Meade, to approve Prevailing Wage Ordinance #171906 for FY2017-18

- b. Sidewalk Café Ordinance Trustee Lindley distributed draft Ordinance to all Trustees

    - 1) It will also be on next agenda
    - Some discussion ensued as to amount of annual fee for sidewalk café permit provision, which ultimately decided \$25 for café (no liquor) was appropriate
    - 3) Fee for ability to serve liquor at sidewalk café was determined to be an additional \$75 yearly, above liquor license fee
