 - 1) There are 2 projects underway along Route 84
 - 2) IDOT cleared the combining of the two projects into one
 - 3) More efficient in costs and engineering to combine the projects, so MSA will proceed in that fashion
 - 3) Have a meeting at IDOT office in Dixon coming up
- b. Task Order for general Engineering Services for \$5000 annually
 - 1) Would hopefully reduce number of individual Task Orders
 - 2) More efficient time-wise as well as will not need to wait for individual task orders
 - 3) It was agreed that when we do get an invoice, and Mayor authorizes for payment, there will be a record in the packet of materials given to Trustees
 - 4) Was previously reviewed and recommended by IRDC
 - 5) Trustee Lindley wants a "cap" on one-time payment
